Terms of Enrollment

This enrollment is not valid unless signed by the parent or guardian of the camper enrolled and accepted by the Camp Director. The signor agrees to pay the tuition and transportation (if applicable) as per the published schedule for this season. If a child, prior to the season, is unable to attend because of appropriately documented illness based on our decision prior to March 1, 2018 all monies will be (less a \$100 processing fee) credited for future enrollment at the discretion of Camp Malibu Inc. based on availability. No refund will be made for late arrival, early departure or dismissal for cause or busing. If tuition is not paid as per the schedule of payment, early enrollment credits will not apply and enrollment may be cancelled and no refund made. For the general welfare of all campers, the Camp reserves the unrestricted right to dismiss any camper whose conduct, or influence, or whose parents, guardians, family members or friends conduct, in the opinion of the Director, is inimical to the best interests of the camp. No refund will be issued in the event of such a dismissal.

It is understood that all photography and videography taken at camp may be used for advertising/ promotional purposes and signor expressly consents to such use of his/ her child's photo/image. Advertising may include newspapers, magazines, radio, camp websites, as well as social networking sites, i.e. Facebook, Twitter etc. It is agreed that in the event that a parent cannot be reached in case of an emergency affecting the camper, permission is given to the child's physician as indicated in the camp records or if unavailable, the physician selected by the camp to administer proper treatment to the child. This contract constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties. In the event that this agreement is executed by one parent, the signor acknowledges that he/she is also acting as agent of the other parent with authority to enroll the child at camp and to execute this agreement on his or her behalf.
