Should a parent not want to send their child for any reason, medical or otherwise, all monies will be held for future years, or at the written request of the family, transferred to another family subject to our approval. If tuition is not paid as per the schedule of payment, or if payment is late, early enrollment credits will not apply and enrollment may be cancelled at our discretion with no credit or refundable.

FORCE MAJEURE. Neither Party will be liable for any failure or delay in performing an obligation under this Agreement that is due to any of the following causes, to the extent beyond its reasonable control: acts of God, accident, riots, war, terrorist act, epidemic, pandemic, quarantine, civil commotion, breakdown of communication facilities, breakdown of web host, breakdown of internet service provider, natural catastrophes, governmental acts or omissions, changes in laws or regulations, national strikes, fire, explosion, generalized lack of availability of raw materials or energy.  
 For the avoidance of doubt, Force Majeure shall not include (a) financial distress nor the inability of either party to make a profit or avoid a financial loss, (b) changes in market prices or conditions, or (c) a party's financial inability to perform its obligations hereunder.

Curriculum and activities are subject to change dependent on all local and state health guidelines. For the general welfare of all campers, the Camp reserves the unrestricted right to dismiss any camper whose conduct, or influence, or whose parents, guardians, family members or friends conduct, in the opinion of the Director, is inimical to the best interests of the camp. This includes any defamatory comments made on any social media outlets. No refund will be issued in the event of such a dismissal.

It is understood that all photography and videography taken at camp may be used for advertising/ promotional purposes and signor expressly consents to such use of his/ her child's photo/image. Advertising may include newspapers, magazines, radio, camp websites, as well as social networking sites, i.e. Facebook, Instagram, etc. It is agreed that in the event that a parent cannot be reached in case of an emergency affecting the camper, permission is given to the child's physician as indicated in the camp records or if unavailable, the physician selected by the camp to administer proper treatment to the child. This contract constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties. In the event that this agreement is executed by one parent, the signor acknowledges that he/she is also acting as agent of the other parent with authority to enroll the child at camp and to execute this agreement on his or her behalf.
